



# LOBBYIST REGISTRATION FORM

In accordance with Lobbyist Registration Policy, this form shall be completed in its entirety and submitted to the GMX Board Secretary. No Lobbying activities shall be performed without first receiving a confirmation receipt that the Lobbyist Registration has been completed. Lobbyist must allow at least seventy two (72) hours for processing of the Lobbyist Registration Form and the issuance of the Lobbyist Registration Receipt.

A. Lobbying Defined: Any individual, firm or corporation employed or retained by a Principal to lobby GMX, which means communicating directly or indirectly, either in person, by telephone, by letter, by electronic means or by any other form of communication, with any member of the GMX Board, Technical Evaluation Committee, or Executive Director, for the purpose of influencing a decision related to any GMX business, even when such GMX business is not under immediate consideration or pending a decision.

No Lobbying activities shall be conducted in the Cone of Silence period during a Procurement Process. (See, Procurement Policy).
