MEYER Now that the Court has ruled that sections 13-17 of HB 385 (2019) are SHELLY SMITH FANO unconstitutional and void ab initio, and because the MDX Board has not met since Governor DeSantis signed HB 385 on July 3, 2019, I am calling a special meeting of the MDX Board at the earliest appropriate date for the purpose of receiving:

- 1) A report on the status, financial condition, and operations and management of the System from July 3, 2019 through the present;
- 2) A report on the issues that the Board must address relating to short-term and long-term projects, contracts, planning, and operational issues, so that the Board can begin addressing those issues at the next regularly scheduled Board meeting; and
- 3) A report from outside counsel on MDX's litigation against the Florida Department of Transportation and the Florida House of Representatives.
