THIS SUPPLEMENTAL AGREEMENT NO. 3 TO DESIGN-BUILD CONTRACT (as "SA #3") is made and entered into this 10th day of January , 2024 (the "Effective Date"), by and between the Greater Miami Expressway Agency ("GMX"), a body politic and corporate, a public instrumentality and an agency of the State of Florida, existing under Florida Statues Chapter 348, Part I, as amended, acting by and through its Governing Board, and Halley Engineering Contractors, Inc., (the "Design-Build Firm"), a Florida corporation located at 13901 Northwest 118 Avenue, Miami, Florida 33178 and duly authorized to conduct business in the State of Florida, Federal I.D. No. 20-4804098 and Travelers Casualty and Surety Company of America (as "Surety"), a Connecticut corporation located at One Tower Square, Hartford, Connecticut 06183 and duly authorized to transact business in the State of Florida, Federal I.D. No. 06-0907370 (collectively, referred to herein as the "Parties" to this SA #3

WITNESSETH

WHEREAS, Miami-Dade Expressway Authority ("MDX") competitively procured for all Services necessary to provide *Design-Build Services for SR 836 New HEFT Ramp Connections* (the "Work"), and subsequently on *February 25, 2022* entered into Design-Build Contract MDX Procurement/Contract No. *RFP-22-01*, with the Design-Build Firm to perform the Work (the "Contract"); and

WHEREAS, on *July 21, 2022*, the Parties entered into *Supplemental Agreement No. 1* to the Design-Build Contract to add specification and incorporate the design changes made by Pevida Highway Designers, LLC to allow for an alternative design, which eliminates the extensive weaving traffic patterns using a new exit identified as Ramp F2 which, greatly improves the safety of the traveling public, while facilitating traffic flow; and

WHEREAS, on *December14,2023*, the Parties entered into *Supplemental Agreement No. 2* to the Design-Build Contract to replace all references of Miami-Dade County Expressway Authority (MDX) with the Greater Miami Expressway Agency (GMX); and

WHEREAS, the purpose of this SA #3 is for the settlement of Additional Work associated with design and construction of the Ramp D-1 modifications required to provide NW 118th Place access to the Park & Ride Lot.

NOW THEREFORE, in accordance with Section 8.3 *Approval Authority of Agreements and Supplemental Agreements* of the Procurement Policy incorporated herein, and in consideration of the mutual promises and covenants contained herein, and for such other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties do hereby agree as follows:

- 1. The foregoing recitations are true and correct and are incorporated herein by reference.
- 2. Exhibit A, Entitlement Analysis and attachments are made part of this SA #3 and are hereby incorporated herein.
- 3. In accordance with *Exhibit A, Entitlement Analysis,* the Additional Work to design and construct the Ramp D-1 modifications required to provide NW 118th Place access to the Park & Ride Lot is hereby incorporated herein.
- 4. Pursuant to Exhibit A, Entitlement Analysis, Four Million, Nine Hundred Eighty-Seven Thousand, One Hundred Sixty-Eight Dollars and Zero Cents (\$4,987,168.00) is herby added to the Contract Amount of Forty-Two Million, One Hundred Twenty-Three Thousand, Two Hundred Ninety-Eight Dollars and Zero Cents (\$42,123,298.00) for a Contract Amount of Forty-Seven Million, One Hundred Ten Thousand, Four Hundred Sixty-Six Dollars and Zero Cents (\$47,110,466.00).

5. Contract Bond Amount

As a result of this SA #3, the Contract Bond Amount of Forty-Two Million, One Hundred Twenty-Three Thousand, Two Hundred Ninety-Eight Dollars and Zero Cents (\$42,123,298.00) is hereby increased by Four Million, Nine Hundred Eighty-Seven Thousand, One Hundred Sixty-Eight Dollars and Zero Cents (\$4,987,168.00) for a Contract Bond amount of Forty-Seven Million, One Hundred Ten Thousand, Four Hundred Sixty-Six Dollars and Zero Cents (\$47,110,466.00).

6. Contract Time

No additional Contract Time is granted as a result of this SA #3 as a result of items 2 through 4 above.

Pursuant to Section 8-20 of the MDX General Specifications for Design-Build (V. 201811) (Exhibit C-1 to the Contract) via Time Extensions dated from 08/01/2022 through 12/4/2023, the Design-Build Firm has been granted fifty-six (60) Calendar Days.

The Contract Time is **seven hundred and thirty-six (740) Calendar Days** with a completion date of **May 17, 2024.**

- 7. As a result of this SA #3, the revised *Subcontractor/Subconsultant Utilization Report*, attached hereto as *Exhibit B* and made a part hereof, shall hereby replace all Small Business Utilization Reports, revised or otherwise, signed prior to the Effective Date of this SA #3.
- 8. The defined terms used herein, unless otherwise defined in this SA #3, shall have the meanings ascribed to them in the Contract Documents.
- Except as expressly provided herein, all of the terms, conditions, covenants, agreements and understandings contained in the Contract Documents shall remain unchanged and in full force and effect, and the same are hereby expressly ratified and confirmed by the Parties.
- 10. This SA #3 shall not alter or change in any manner the force and effect of the Contract except insofar as the same is altered and amended by this SA #3. Wherever the terms of this SA #3 and the terms of the Contract Documents are in conflict, the terms of this SA #3 shall govern and control.
- 11. The Parties hereby agree the consideration expressed in this SA #3, that the monetary sum(s) agreed to herein constitute a full and complete settlement of all the matters relating to and set forth herein, including, but not limited to, all direct costs for equipment, manpower and materials, as well as indirect costs, expenses and profit (inclusive of overhead of any kind) and delay damages relating to the issues set forth in this SA #3. The settlement outlined herein, is limited to and applies only to any claims arising out of or on account of the matters described and set forth in this SA #3 which constitutes the totality of SA #3.
