SR 836/Dolphin Expressway

Lane Closures

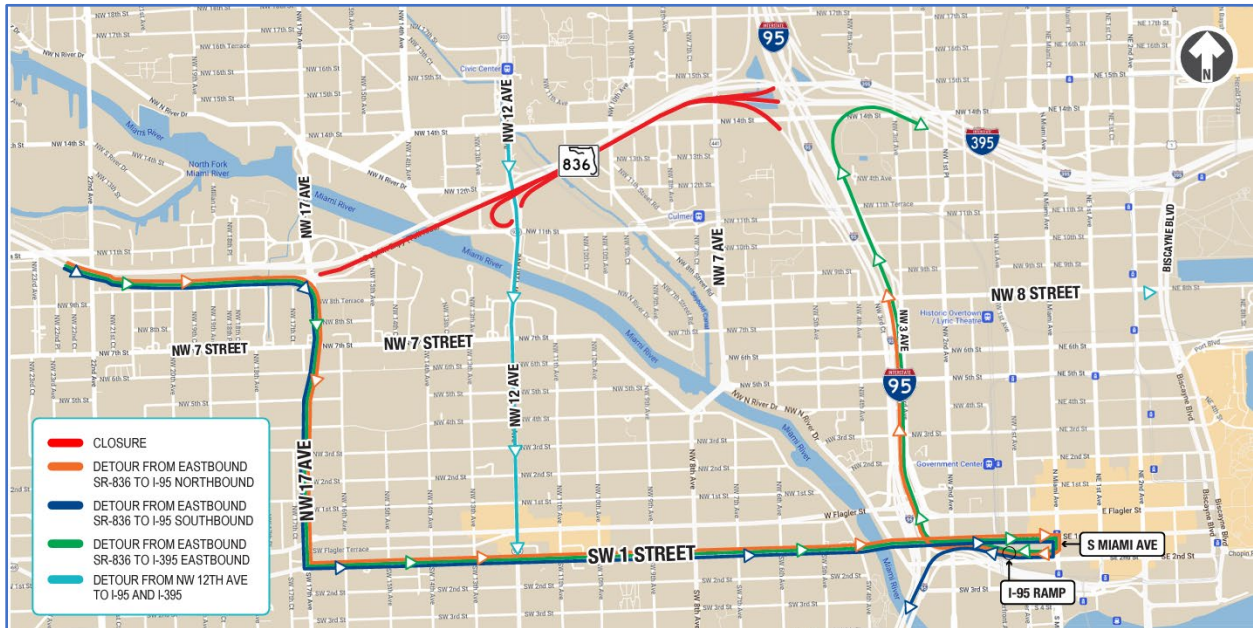
A single lane on northbound and southbound NW 121st Avenue/Telemundo Way will be closed for roadway work on **Tuesday, May 21 through Friday, May 24 from 9 a.m. to 3:30 p.m. each day.**

Ramp Reduction

A single lane on westbound SR 836/Dolphin Expressway exit ramp to northbound SR 828/Palmetto Expressway will be closed for bridge maintenance on **Sunday, May 19 through Friday, May 24 from 11 p.m. to 5 a.m. each night.**

The following closures are part of the I-395/SR 836/I-95 Design-Build Project. This schedule may change due to bad weather or other unforeseen conditions.

COMPLETE CLOSURES OF EASTBOUND STATE ROAD (SR) 836 AT NW 17TH AVENUE START MAY 17



Starting on Friday, May 17, complete closures of eastbound SR 836 will be implemented from NW 17 Avenue to I-95 to safely construct a bridge support structure that will span the entire width of eastbound SR 836 just west of I-95 as shown below. The structure will support the new double-decked roadway and will be constructed in place, using four major phases over approximately three months.



GREATER MIAMI EXPRESSWAY

Initial closures to start the construction of the structure will be implemented as noted below:

- 11 p.m. Friday, May 17 until 9 a.m. Saturday, May 18
- 10 p.m. Saturday, May 18 until 8 a.m. Sunday, May 19
- Nightly on Sunday, May 19 through Thursday, May 24, between the hours of 10 p.m. and 5:30 a.m.

Drivers on eastbound SR 836 will:

- Exit at NW 17th Avenue, then continue south across NW 7th Street
- Turn left at SW 1st Street and continue east
- Turn right at South Miami Avenue
- Turn right to access the ramp to I-95 north or south

Drivers going to Biscayne Boulevard and the MacArthur Causeway can continue north on I-95 and access exit 2D to I-395 east

Drivers on NW 12th Avenue wanting to access eastbound SR 836, I-95, Biscayne Boulevard, and the MacArthur Causeway can continue south on NW 12th Avenue, turn left at SW 1st Street, and follow the detours above.

SUNDAY, MAY 19 THROUGH FRIDAY, MAY 24 – Up to two lanes on eastbound SR 836 from NW 17th Avenue to I-95 will be closed as needed between the hours of **9 p.m. and 5:30 a.m.**

SUNDAY, MAY 19 THROUGH FRIDAY, MAY 24 – Up to two lanes on westbound SR 836 from I-95 to NW 17th Avenue will be closed as needed between the hours of **9 p.m. and 5:30 a.m.**
