SR 836/Dolphin Expressway

Lane Closures

The single lane on eastbound SR 836/Dolphin Expressway will be closed between NW 137th Avenue and Florida's Turnpike for barrier wall relocation on **Wednesday**, **May 1 from 10 p.m. to 5:30 a.m.**

Lane Closures

Up to two lanes on eastbound and westbound SR 836/Dolphin Expressway between NW 27th Avenue and NW 57th Avenue will be closed for bridge maintenance on **Sunday**, April 28 through Tuesday, April 30 from 11 p.m. to 5:30 a.m. each night.

The following closures are part of the I-395/SR 836/I-95 Design-Build Project. This schedule may change due to bad weather or other unforeseen conditions.

SUNDAY, APRIL 28 THROUGH FRIDAY, MAY 3 – The northbound I-95 ramp to westbound SR 836 will be closed between the hours of **10 p.m. and 5:30 a.m.** for lighting maintenance. Drivers can:

- Enter the eastbound I-395 ramp
- Exit at NE 2nd Avenue/Biscayne Boulevard (Exit 2B), then turn right on NE 2nd Avenue
- Turn right on NE 11th Street
- Turn right on NE 1st Avenue to access westbound I-395 to continue onto westbound SR 836

SUNDAY, APRIL 28 THROUGH FRIDAY, MAY 3 – The eastbound SR 836 ramp to northbound I-95 will be closed as needed between the hours of 9 p.m. and 5:30 a.m. Drivers can:

- Access the southbound I-95/NW 8th Street Ramp, continue south on I-95
- Exit at SW 7th Street/Brickell Avenue (Exit 1B), then turn left at SW 8th Street
- Enter the northbound I-95 ramp

THURSDAY, MAY 2 AND FRIDAY, MAY 3 – The eastbound SR 836 ramp to southbound I-95 will be closed between the hours of **9 p.m. and 5:30 a.m**. Drivers can:

- Continue east on I-395
- Exit at NE 2nd Avenue/Biscayne Boulevard (exit 2B)
- Turn right on NE 2nd Avenue, then turn right on NE 8th Street
- Then turn left on NW 3rd Court
- Continue south on NW 3rd Court to access the I-95 south ramp after NW 2nd Street

SUNDAY, APRIL 28 – All southbound lanes on I-95 will be closed at SR 836 between the hours of **11:45 p.m. and 5:30 a.m.** for overhead work.

Non-Tolled detour route for southbound I-95:

- Exit at the SR 836 West Ramp, then exit at NW 14th Street
- Turn left at NW 12th Avenue, then turn left at NW 11th Street
- Turn right at NW 8th Street Road, then turn left at NW 8th Street
- Turn right at NW 3rd Court to access the I-95 south ramp after NW 2nd Street

Tolled detour route for southbound I-95:

- Exit at the SR 836 West Ramp, then exit at NW 12th Avenue
- Turn left at NW 12th Avenue to access the SR 836 east entrance ramp
- Continue west on SR 836 to access the I-95 south ramp



SUNDAY, APRIL 26 THROUGH FRIDAY, MAY 3 – Up to two lanes on eastbound SR 836 from NW 17th Avenue to I-95 will be closed as needed between the hours of **9 p.m. and 5:30 a.m.**

SUNDAY, APRIL 26 THROUGH FRIDAY, MAY 3 – Up to two lanes on westbound SR 836 from I-95 to NW 17th Avenue will be closed as needed between the hours of **9 p.m. and 5:30 a.m.**
